We salute each and every one of you and offer our heartfelt THANK YOU for your compassion, dedication and commitment to the people we serve.





Arc Human Services purchased the Brody Building at 111 West Pike Street in Canonsburg with plans to relocate our corporate headquarters bringing more than 60 employees downtown.

Construction began in February 2020 and the 4th floor, designated as Administrative Office Space, was completed and ready for occupation by November 30, 2020. Additional staff were moved to the Lower Level in June 2021. Remodeling continues on the 1st floor (Pike Street entrance) with Chicco Baccello and community art gallery occupying this area; plans for their Grand Opening are on hold at this time.

Horses with Hope

Arc Human Services saddled up with a Bethel Park nonprofit, Horses with Hope, to provide equine-assisted learning experiences for our individuals.

Grishma Solanki, Director of MH and Clinical Operations, stated that during the sessions, "We talked about how horses really need humans to support them in their daily activities and routines."

"Our individuals learned how to approach such a large animal, but still respect their personal space and boundaries. They also learned about grooming techniques and tools and what horses look like when they're allowing us to be in their space. Each session built upon those interpersonal skills, problem solving and communication, both verbal and nonverbal."

Ann Davis, founder of Horses with Hope, saw much improvement from individuals with Arc throughout the sessions, which was exciting for everyone.


Davis said it was very humbling since they're very passionate about the things they do. "I'm here just to help people improve their quality of life and to overcome what fears and anxieties they have, that possibly held them back for years and sometimes decades".

Grishma Solanki was impressed with the stride's individuals were making throughout the sessions. She said one individual, Sean, who was never very talkative, acquired assertiveness and communication skills while working with the horses.






